In accordance with a letter of agreement between AFT- Local 1521, hereinafter referred to as 'Client' and the American Arbitration Association, hereinafter referred to as 'AAA', an Election of Officers was conducted among the membership of the union.

An Electronic voting process was conducted among ten (10) Campuses /Emeritus for voting on Campus Candidates as well as the Districtwide Officers. That electronic voting opened on April 12, 2024, at 9:00AM, and two email reminders were out sent on April 19th and April 29th at 9:00AM. A small portion of twenty-seven (27) of the Emeritus unit was conducted as a mail ballot and went out on April 1, 2024 and were due back by 5:00PM on April 30th. The Client provided the AAA with an alphabetical list of persons who were eligible to vote. The counting of the Emeritus ballots took place remotely on Tuesday, April 30th at 5:00PM. Electronic voting closed at 11:59PM, on Thursday, May 2, 2024, and all votes were tallied for combined results. Secrecy of the ballot was maintained at all times.
